

ORDINANCE NO. 14

RECODIFICATION OF ORDINANCES

AN ORDINANCE TO REVISE, REPEAL AND RECODIFY THE ORDINANCES OF THE VILLAGE OF DEERFIELD, PURSUANT TO THE PROVISIONS OF ACT 3 OF THE PUBLIC ACTS OF 1895 AS AMENDED BY ACT 18 OF THE PUBLIC ACTS OF 1979.

THE VILLAGE OF DEERFIELD ORDAINS:

Section 1. REPEAL OF ORDINANCES

The following ordinances are hereby repealed:

- a. Sidewalk snow removal ordinance.

- c. Automobile trailer ordinance.

- d. Disorderly conduct ordinance.

- e. Cruelty to animal ordinance.
Date of Enactment: November 4, 1968.
- f. State construction Code Ordinance - Plumbing Code
Date of Enactment: May 5, 1975.
- g. State Construction Code - General Construction
Date of Enactment: December 4, 1974.
- h. Uniform Traffic Code
Date of Enactment: July 18, 1977
- i. Amendment to Uniform Traffic Code
Date of Enactment: May 19, 1980

Section 2. RECODIFICATION

The remaining Ordinances of the Village of Default are hereby recodified as follows:

- a. Village Zoning Ordinance is now Ordinance 1.
- b. Dangerous Buildings Ordinance is now Ordinance 2.
- c. Sewer Use and Rate Ordinance is now Ordinance 3.
- d. Water Supply System Ordinance is now Ordinance 4.
- e. Water Connection Ordinance is now Ordinance 5.
- f. Weed Control Ordinance is now Ordinance 6.
- g. Flood Hazard Ordinance is now Ordinance 9.
- h. Littering Ordinance is now Ordinance 10.
- i. Curfew Ordinance is now Ordinance 11.
- j. Dog Control Ordinance is now Ordinance 12.

k. Domestic Animal Ordinance is now Ordinance 13.

This Ordinance shall take effect 20 days after its passage.
